





Workforce financial stability

52 percent of employees have less than \$1,000 to pay for unexpected out-of-pocket medical expenses; **27 percent** of employees have less than \$500.

46 percent of employees would need to borrow from a 401(k) or use a credit card to cover unexpected medical costs.

8 percent of employees say high medical costs have negatively impacted their credit scores.

10 percent of employees have been contacted by a collection agency about outstanding medical bills.
